

Chancery Land Deed

Made the 26th day of September in
the year Nineteen Hundred and thirty four

Between Mana H. Wright and George J. VanAntwerp and Mary L. VanAntwerp, his wife, all of the Town of Cicero, N. Y.

party of the second part.

Witnesseth, that the said party of the first part, in consideration of One Dollar and other valuable consideration ~~holders~~, lawful money of the United States, paid by the party of the second part, do hereby grant and release unto the said party of the second part, her heirs and assigns forever, ALL THAT TRACT OR PARCEL OF LAND situate in the Town of Cicero, County of Onondaga and State of New York briefly described as follows: Being part of town lot No. forty seven (47) of the Town of Cicero, and cottage lot No. 42 as shown on a map made by H. S. Wells, surveyor, titled "VanAntwerp Beach Section" and filed in the Onondaga County Clerk's Office.

Also right of ingress and egress from the said lot to the public highway subject however to the following conditions and restrictions, which shall be covenants running with the land, viz:

1. That any cottage erected on said premises shall cost not less than \$500.00.
2. That no cottage shall be erected on said lot which shall project beyond the building line as laid down on a map of "VanAntwerp Beach" made by H. S. Wells, surveyor.
3. That it shall not be sold or rented to Negroes, Italians, Poles or Jews.
4. That the premises above described shall not be used for the manufacture or sale of intoxicating liquors nor as a location for

any business.

Together with the appurtenances and all the estate and rights of the parties of the first part in and to the said premises.

To have and to hold the above granted premises, unto the said party of the second part, her heirs and assigns forever.

And the said parties of the first part, do covenant with said party of the second part as follows:

First. — That the said parties of the first part, are seized of the said premises in fee simple, and have good right to convey the same.

Second. — That the party of the second part shall quietly enjoy the said premises.

Third. — That the said premises are free from encumbrances.

Fourth. — That the parties of the first part will execute or procure any further necessary assurance of the title to said premises.

Fifth. — That the said parties of the first part will forever warrant the title to said premises.
